

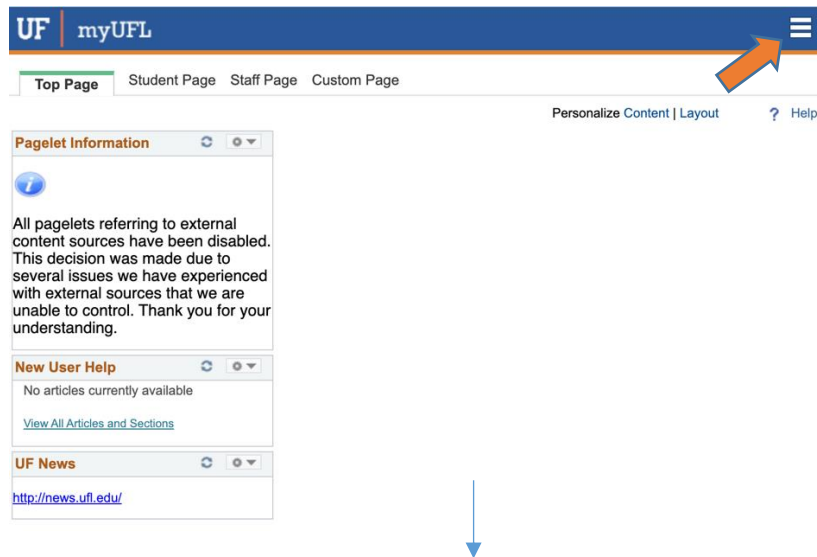



ACCESSING W-2 INFORMATION

The following instruction guide will show you how to access your W-2 information on my.ufl.edu.

My UFL Access Instructions:

- Navigate to my.ufl.edu
- Click the blue "ACCESS MYUFL" button
- Login with your UFID and password
- Access the white NavBar in the upper right side of the screen and click Main Menu
- Once in the Main Menu, navigate to My Self Service > Payroll and Compensation > View W-2/W-2c Forms.
- Enter your social security and date of birth to access your form(s)
- Click the appropriate year under "Year End Form" for the form you need






